# BERQNET CONNECT APPLICATION PRIVACY POLICY

This privacy policy ("Privacy Policy") relates to the confidentiality of your information that you shared and / or obtained during the process of using Bergnet Connect Application ("Application").

Using the Application means that you have read and accepted the Privacy Policy. If you think that you cannot fulfill the obligations stipulated in the Privacy Policy, do not use the Application.

#### 1. USER INFORMATION

Responsibility for all kinds of information including identity and contact information transmitted, sent, uploaded, recorded and / or entered on the Application belongs exclusively to the relevant user. ### 2. PROTECTION OF INFORMATION

### 3. PERSONAL DATA

### 3.1 Personal Data Collected and Processed

In accordance with the Turkish Law on the Protection of Personal Data No. 6698 ("Law"), any information regarding an identified or identifiable person is personal data ("Personal Data"). Name, surname, telephone number, e-mail address, user device IP address, connected server IP address, device hardware and operating system information, date and time of use and similar Personal Data may be transmitted, sent, uploaded, recorded and / or entered on the Application. Users; considering that these Personal Data will be open to Logo Siber Guvenlik under the terms of the Terms of Use, have disclosed this information and that any Personal Data transmitted to the Application by the user loses its privacy against Logo Siber Guvenlik.

### 3.2 Special Categories of Personal Data

Logo Siber Guvenlik, as long as not required by the law, in any way and absolutely; does not request data on race, ethnicity, political opinion, philosophical belief, religion, sect or other beliefs, attire, association, foundation or union membership, health, sexual life, criminal conviction and security measures, and biometric and genetic data. Logo Siber Guvenlik has no responsibility as this information is given, recorded or disclosed on the Application.

# 3.3 Collection and Recording of Personal Data

Logo Siber Guvenlik collects Personal Data from the user through user uploading, transferring or saving it through the Application.

## 3.4 Personal Data Processing Purposes and Activities

Logo Siber Guvenlik can process, store, classify Personal Data in databases, use it in line with the purposes and / or services of Logo Siber Guvenlik, in accordance with the legislation, can transfer it abroad, share it with third parties.
